Core Strategies

ADVOCACY: Our advocacy activities are grounded in the belief that nonprofits deserve sustainable resources, fair treatment, and equity. We advance this work through a targeted policy agenda and collaboration with partners across the sector.

CAPACITY BUILDING: Our capacity building program evolves to meet sector needs. We provide learning opportunities and member benefits that support core functions and help nonprofits strengthen leadership, improve decision-making, and build resilient financial, operational, and organizational systems.

CONVENING: Bringing organizations together is critical to a strong nonprofit ecosystem. We convene nonprofit professionals, from entry- to executive-level staff, to foster collaboration, shared learning, and collective action across the sector. Our Annual Conference is a flagship forum for connection, learning, and the exchange of ideas that move the sector forward.

RESEARCH: We conduct research to understand sector challenges and identify solutions. Our work informs policy and strategy, documents the sector's economic impact in NYC, and provides critical compensation data.

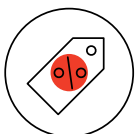
